## **Radio Officer's Report**

I wish to thank you for allowing me to serve the Mike & Key Amateur Radio Club as Radio Officer again. The reason that I decided to become active again in this capacity is two-fold.

First, I had concluded my active participation in the Western Washington Amateur Relay Association (WWARA). This group is the coordination group that provides information and coordination service for amateur radio repeaters in Western Washington. In addition the WWARA is active and participate in the national coordination counsel the NFCC and Mid Mountain Coordination counsel (MACC). Secondly, I was asked by several members to step in and volunteer for the Radio Officer's position. Having the time, interest, ability, and the qualifications I decided to accept the challenge.

As many of you may not know, several of the members, nearly 25 years ago, negotiated and obtained a repeater system operating on 146.82 for the Mike & Key Amateur Radio Club. The club is the third occupant of '82 in Western Washington. The original repeater owner was Woody Baker W7RC and the '82 machine was operated from his home in the Renton Highlands. Several years later we were able to obtain from the ICOM Company our current repeater. After several years of power supply problems, we purchased an external power supply and the system, for the most part, has operated reliably the last 15 years. From memory, it has been off the air only two times in the past 15 years. The Mike & Key Club also owns the duplexer and antenna, a 6db DP Products gain antenna. Our host, who allows us to operate from his site, has provided all of the coax and other services. This has included maintenance and repairs of all the external hardware, towers and items that can cause interference, and cause lack of performance to the repeater receiver.

In addition, the original repeater package has been used, on occasion, as a back up system from the

West Seattle area, however all the parts & pieces were assembled by the previous owner and there is minimal documentation. That system has a transmitter output of about 5 watts and an amplifier that will provide about 45 watts of power. Included with the old system is a 4-can duplexer I purchased for the club at one of our flea markets for \$175. (By comparison, the new duplexer that was purchased by the club last year was about \$1500.)

The club has now purchased a new repeater. I have been given the task to activate the "New 2-meter" repeater. The new machine is currently in operation from the Overdale Park Water association's water tank in Issaquah running only 15 watts from the duplexer. The plan would be to move the new machine to the mountaintop after its operation is proved and decisions have be made as to the power output and installation of an FCC approved control system. The current ICOM repeater would then become the back up and could be operated from the Overdale park site as a back up system. The Overdale Park site, along with the installed antenna system and coax feed line, come as a donation (as in free) if the coverage is deemed adequate as a site for a "Standby system".

Try out the "New 2-meter" repeater. It's on the air using a 100Hz tone. Your received signal may be noisy as the power output is low, The repeater also transmits a 100 Hz so that the mobiles can use "tone squelch" which eliminates the need to keep resetting your receiver's squelch. Its tone will be changed to the 103.5 Hz when the move is made. If using the "Standby" repeater, be careful not to interfere with the main repeater system.

That's about it for now. I will present more information later about the 220 MHz machine and the other responsibilities that I am required to perform as your Radio Officer. ## Hi Ya All, It's me again

I am somewhat concerned about the recent VE test session at the Flea Market. Although the overall passing rate was ok, there were a number of failures. Years ago, I went to a teaching school. One of the subjects taught was test construction. Our POI (plan of instruction) was to be constructed so that all of the subject material was covered and, in fact, emphasized those items that would be in the test. Each test question would have one correct answer, two detractors (nearly right answers) and one throw away which was a totally and obviously wrong answer. OK, that is great for the classroom, but how does one who is studying for the test incorporate that information from a book — without attending formal class instruction?

Consider this; the ARRL study manuals have the test pool questions for each class of license in the back if the book. In that section you will find the guestions and answers. Additionally, there is a little box that gives the chapter, page, and paragraph where the correct answer is explained in detail. I strongly believe that when one is studying for a license, simple memorization is not sufficient

for passing the test and obtaining a license. You must have a modicum of basic knowledge that is not covered in the test to become a basic amateur operator. There are many aspects to amateur radio that are not covered in the test. Along with that "Now You Are Talking" study manual, you should also read the "Amateur Radio Operators Guide". A book that will introduce you to operating techniques, station construction, safety, and many other subjects in the realm of becoming a good operator. Anyone can key a microphone and talk, that is called "CB".

Oh yes, what to do with the study manual? Well, I suggest you procure a highlighter pen and, in the question section, you highlight the correct answer. Now that will take a little effort, more to come. Go back and find the page paragraph and line of text that is referenced for the question and, in the front of the book, the part you read, locate the text that pertains to the question and highlight that text. You will have a lot of color in both sections when you are finished, BUT you are not finished. Now, you must read the book, paying close attention to the highlighted text. You read a section twice, reading slowly and relaxing between reading sessions. After reading the text two times, go back and review the test questions again em-






